B.1 29 Overlook Terrace, Amended Site Plan, Emergency Generator

Justin David, of MD7 representing the applicant, explained they made the requested changes asked for in December and distributed them to the Board for review. The noise volume in question is 71 decibels and the height of the unit is 99 inches tall, and the fence is 8 feet tall and is shielded so it would be 3 inches taller. The generator will run for 30 minutes during the week at the time the Board deems during the day time. It's a far set back, about 100 feet, to the nearest surrounding parcel so it should not be very noticeable.

Attorney Dickover stated that this is an amended site plan application. Application complies with all the issues. Was referred to the County and came back with local determination. The Board could do a public hearing if you choose to do so. The Board already declared itself lead agency, review, and typed it as an unlisted action so we need to do the environmental review.

The Board reviewed the short form EAF aloud with all items answered no by the Board.

Member Pearson made a motion based on the answers to the EAF that the 29 Overlook Terrace, Amended Site Plan, Emergency Generator project could not result in any significant adverse environmental impacts. Seconded by Alternate Member Kraus. All ayes. Motion carried.

Attorney Dickover stated the next issue is if you will require a Public Hearing.

Member Pearson made a motion to waive the Public Hearing for the 29 Overlook Terrace, Amended Site Plan, Emergency Generator. Seconded by Member Trafton. All ayes. Motion carried.

Member Trafton made a motion to grant the application for 29 Overlook Terrace, Amended Site Plan, Emergency Generator. Seconded by Alternate Member Kraus.

Member Trafton amended his previous motion to include that the application for 29 Overlook Terrace, Amended Site Plan, Emergency Generator be approved subject to the Village
